**CONSERVATION COMMISSION MEETING
APRIL 18, 2012**

MINUTES

Present: Bonnie Geromini, Philip Grant, Judy McKinley Brewer,

- 7:00 P.M.** Mr. Rick Green, Selectmen for Hampden talked first about Mr. Dorn's property. They are requesting permission to clear up his riverfront area at his home at 45 River Park with the fallen trees from the slash dam. They are afraid that if it is not done soon that it will change the way the river flows and property owners may have flooding. Mr. Green would like a 30 day emergency permit to allow the work specified. The work will be done by hand without the use of wheeled or tracked vehicles in the resource area. Mr. Green had pictures that Mr. Dorn had taken of the Scantic and his property showing the damaged trees that are into the river on his property. Mr. Green is going to write a letter to the Hampden Conservation Commission on Mr. Dorn's behalf requesting an emergency permit and send the pictures along with the letter.
- 7:20 p.m.** Melissa Trekor of 337 North Rd. had questions about taking down storm damaged tree hangers that are on her property. She has Northern Tree coming in to do the work and wanted to know just what she was able to cut and be legal within the boundaries. An Emergency Permit will be issued to her.
- 7:40 p.m.** Mastronardi property on Mt. Vision Rd. It was decided to meet with Mr. Edwards at the site to talk about the tree cutting on the property. The commission will ask for a site date of April 26, 2012 at 5:00 p.m. Judy McKinley Brewer will be sending Mr. Edwards an e-mail on the site visit.
- 7:50 p.m.** Kelly Lane addition. Mr. Grant will be calling Mr. Benjamin who is the architect for the project and will have him check with us when the drawings are completed.
- 7:55 p.m.** The minutes of the March 21, 2012 meeting were discussed with no changes or additions. Bonnie Geromini made the motion to accept the March minutes, Pat Cote 2nd the motion. Phil Grand and Judy McKinley Brewer were in favor.
- 8:00 p.m.** Bonnie Geromini made a motion to close the meeting at 8:00 p.m. All were in favor.
