

# SPECIAL TOWN MEETING WARRANT

## TOWN OF HAMPDEN

**TO:** The Constables of the said Town of Hampden in said County:

**Greetings:** In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Hampden qualified to vote in a special election and in Town affairs, and to meet at Thornton W. Burgess Middle School, Wilbraham Road, Hampden, on Monday, November 9, 2009 at seven o'clock in the evening, then and there to act on the following articles:

**Article 1. FIRE DEPARTMENT BUILDING MAINTENANCE-** To see if the town will vote to raise and appropriate and/or transfer from unappropriated available funds a sum of money for Fire Department building maintenance and repairs, or take any other action relative thereto.

**Article 2. FIRE DEPARTMENT PROTECTIVE EQUIPMENT -** To see if the town will vote to raise and appropriate and/or transfer from unappropriated available funds, a sum of money to purchase protective equipment for fire department members, or take any other action relative thereto.

**Article 3. TOWN HOUSE MAINTENANCE -** To see if the town will vote to transfer from available funds, a sum of money for replacement of the HVAC system in the Town House, or take any other action relative thereto.

**Article 4. TOWN HOUSE MAINTENANCE AND REPAIR-** To see if the Town will vote to raise and appropriate and/or transfer from unappropriated available funds, a sum of money for various maintenance and improvements for the Town House, or take any other action relative thereto.

**Article 5. COMMUNITY PRESERVATION COMMITTEE -** To see if the Town will vote to hear the report and recommendations of the Community Preservation Committee, which include transfer requests, or take any other action relative thereto.

**Article 6. HIGHWAY DEPARTMENT BUILDING MAINTENANCE -** To see if the Town will vote to raise and appropriate and/or transfer from unappropriated available funds, a sum of money to do various building repairs, including reroofing the salt shed roof, block work restoration, and other maintenance work, or take any other action relative thereto.

**Article 7. BOARD OF ASSESSORS** - To see if the Town will vote to transfer a sum of money from the Assessor's Stabilization Fund for the FY2010 Interim Year services.

**Article 8. STABILIZATION** - To see if the Town will vote to raise and appropriate from unappropriated available funds a sum of money for transfer in to the Stabilization Account, or take any other action relative thereto.

And you are directed to serve this Warrant by posting an attested copy thereof at each of the five places designated by the Town. Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk at or before the time of the meeting aforesaid. Given under our hands this 23rd of October 2009.
